

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Passivehouse level standards are the right way for domestic housing if we are treating the climate emergency properly. I do wish the bill spoke to the retrofit challenge by setting up a framework to progress this but its an excellent start.

Vast supply chain issues and significant industry push back so it would need to be carefully introduced to larger schemes first in a simple staged way. Very doable though. Everyone complained about section 6 energy emission standards when they were introduced but nobody notices anymore. Just needs care.
