# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

I think the process as described seems fine, my only concern is, that while good standards need to be met - if the process involves huge consultation costs, large quantities of paperwork and bureaucracy and is not flexible enough to accommodate local differences - it may prove difficult to implement. Simple and flexible systems would be my first choice.

#### Q6. What could be the market effects of the introduction of this proposal?

I don't know, I'm not an economist. But I imagine good quality housing stock may be more costly to produce and people may choose to stay in their house rather than move - but ultimately this is what we need to live sustainably - so maybe our market models need to change to reflect longer term aims and benefits, rather than short term gains.

Yes, all of these. Sensitively built housing, taking on board the needs of individual communities, local biodiversity and joint community needs - could be both positive for people and environment. Shared communal facilities could further enhance the sustainability aspects of such projects, along with the low carbon passive housing.

#### General

Q10. Do you have any other additional comments or suggestions on the proposed Bill (which have not already been covered in any of your responses to earlier questions)?

It was mentioned in the paper about focussing on new housing and I understand that it can become too large to think about existing housing within this paper too. But, I think this is an equally important aspect of sustainable housing and would merit a companion paper on this topic. I assume the amount of existing housing stock in Scotland that is well below modern energy efficiency ratings, must be extremely high. While there have been schemes to improve this - they seem to come and go and many are not affordable for the many in income brackets that don't involve benefits, but don't don't have the kind of disposable income that would allow for solar panels or air source heat pumps, cavity wall insulation etc. Many of these households want to improve to their energy efficiency but don't have the finances to do it. They continue to pay extortionate bills - costing individuals a lot of money and costing the planet - in terms of climate change. I would like to see a nationwide scheme to gradually improve all housing stock to basic standards of insulation and support to fund renewable sources of energy - either via individual households or via local community schemes run to provide low cost energy for local communities.
