Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

It has been proven in practice that Passivhaus homes can be built to a similar cost to current building regulations standards. In turn this might increase the attractiveness of new-build homes, therefore improving the market. Owners and occupants will spend less money on energy bills, which in turn will allow them to spend their money on other, potentially more local, things, thereby keeping money in the local/national market. These homes will also provide the opportunity for increase training of local skills. They will allow for national reduction in energy consumption, and therefore maximise reliance on national renewable energy sources, rather than imported energy.
