Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Passivhaus is the only standard available for homes that provides significant environmental benefits/savings as well as improving the health and wellbeing of occupants and addressing fuel poverty at the same time.

Yes, when it comes to environmental issues the best way to achieve the aims is to legislate - take for example in England Part L1A/B and Home Quality Mark. We must build homes to meet the standards set out in Part L1A (and refurbishments to L1B) but Home Quality Mark is voluntary and is therefore not used/actively ignored by the house building sector.

Passivhaus homes have been shown time and time again to significantly reduce energy demand for heating, to the extent that some occupants have never had to turn on a heating system in over 10 years of occupation. At a time when heating costs are skyrocketing, Passivhaus offers a sustainable solution to address fuel poverty.

Until workforce training has upskilled our existing construction workforce, it could result in a downturn in house building rates - however I'm sure the Scottish Government could do a better job than the UK Government in providing funding and opportunities to upskill the workforce
