Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

We have the ability to build houses that are truly 'affordable', that are inflation proof against the rising cost of energy.

If the standard was adopted homes would cost no more than 10% to build, but the savings in energy costs would last the life of the home.

The improvement in air quality would create a healthier environment for the residents.

The Passivhaus standard is not prescriptive in build style, it is a method of measuring the real energy performance of a building.

House building companies and developers are purely focused on the bottom and their shareholders. The carrot and stick approach could be an interim measure, with say a 60% reduction in council tax on the new build property, but that would put pressure on the local authorities and they would need reimbursement for the loss of income.

Another possibility would be to substantially increase the fees of building warrants for any property not conforming with the passivhaus standard until legislation is enacted.

Also worth noting is builders with historic building warrants on large developments are more than happy to continue to build lower standard houses for years to come!
