

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Domestic combustion contributes 50% of air pollution in Scottish towns and is a major contributor to CO2 concentrations. Building better insulated houses is a necessary and overall economic way of contributing to slowing climate change.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Experience with other public health measures has shown legislation is effective while other measures are much less so. Climate change is already having adverse effects on physical and mental health viz heat waves and flooding
