# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

#### Please explain the reasons for your response.

Passive House quality standard is realistic and achievable, and needs to be a key component to drive our net zero strategy across the uk. Having commissioned a PHPP report on my home and being able to achieve >90% energy reduction is clear that Passive House is the right way forward to dramatically reduce our demand for energy. Passive House standard should not be an option, rather the standard going forward for all new builds, with far greater support on Retrofits to Passive House EnerPHit standards.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Yes. The building regulations don't go far enough and the quality is insufficient. For example MVHR (Mechanical Ventilation and Heat Recovery) is not incentivised. Homes are still built with deliberate energy leaks through trickle vents in windows.
