

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

**Please explain the reasons for your response.**

Affordable warm homes contribute to improved cognitive skills and people having spare cash to socialise with; consider further studies or to take their children to activities where they can learn how to mix with others and build confidence.

Many existing properties are not suitable for improvements because they were built with materials, such as stone that take a lot of energy to heat or poor materials which cause draughts. Improvement costs are prohibitive for many of these homes due to lack of services such as no main gas supply and expensive electricity. It is much easier and cheaper in the long run to ensure that new homes make use of new building materials and developments such as underfloor heating or communal electricity generating projects for example.
