# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

#### Please explain the reasons for your response.

With an ongoing cost of living crisis and full poverty in Scotland getting worse, we must take action to reduce energy consumption and costs. Scotland is continually failing to meet its climate targets and it is vital that we take action to address the climate crisis by reducing our energy consumption and emissions. This Bill will ensure that new any new houses built will reduce energy demand and cut fuel bills for families across the country.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I believe that legislation is required to ensure all new houses are built to a Scottish legal minimum standard in order to help reduce consumption. The current plans put forward by the Scottish Government to ensure all new build homes built to energy rating C is reliant on expensive electric heating replacing gas fuelled boilers, which will increase demand on the grid and continue to produce CO2 emissions. We need legislation to ensure the introduction of the Passivhaus or an equivalent standard because this building standard can be achieved without the use of energy and it is a verifiable measure based on actual performance rather than the Energy Performance Certificate system, which is a theoretical model.

Passivhaus construction will also eradicate the performance gap, which is the difference between how a new home is expected to perform and how it actually performs in relation to energy efficiency.

Building standards should be able to be verified and evidence should be submitted to ensure that there is no performance gap. As stated previously, Passivhaus construction is a verifiable measure based on actual performance as opposed to the current Energy Performance Certificate system which is the theoretical model.

Q6. What could be the market effects of the introduction of this proposal?

The introduction of this proposal will support the growth of the supply chain in Scotland by creating skills and jobs, providing Scotland with the opportunity to be a world leader in this sector. Existing house builders who have moved from traditional construction methods to Passivhaus standards have invested in upskilling their workforce. They found that this has increased the pride architects and tradespeople take in their work and has improved skills. Reports from companies in Ireland and Scotland who have already taken this approach have been very positive.

#### cost-effectively.

There is an estimated additional capital cost of building to the Passivhaus standard, which is between 4%-8% of the total build. However, greatly improved energy efficiency will result in savings on heating bills and reduced emissions which will save money in the long-term. Builders have reported that the cost of improvements to buildings at the construction stage is much lower than retrofitting at a later date and has the added benefit of lower CO2 emissions and energy consumption from the outset.

It is my view that there are no adverse impacts expected from passing this legislation. The proposal will benefit people on low incomes and those with disabilities, for example by reducing energy bills and preventing the need for retrofitting in the future. This proposal will have a positive impact on everyone, including wider society as we strive towards reaching our climate targets.

This proposal can be part of the solution to net zero because it will reduce both emissions and the consumption of energy in our homes. Scotland currently has the highest level of people living in fuel poverty in the UK at 25%. Adopting Passivhaus or equivalent standards will reduce the energy demand for heating by up to 90% (compared to existing housing stock), cut fuel bills and reduce emissions, which will greatly benefit families and the environment. This proposal is an excellent way for Scotland to make strides towards both meeting our crucial climate targets and eradicating fuel poverty in the future.
