# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

It would reduce the cost of housing and reduce the cost of running them. Passiv houses are built off-site and assembled on site. This contrasts with the UK approach of building on site, whereby materials are bought of the site and the structures are built. Passiv houses are kit built, off-site, in a centralised factory, and assembled onsite. Also known as kit houses it is far lower cost, and efficient, using less energy and producing less waste. The centralised construction sites offer superb opportunities for continuous, well paid skilled jobs. Transitioning Scottish house building to off-site construction will reduce housing costs, and create jobs, whilst also reducing the carbon footprint of construction. If adopted then Scotland could create an strong export industry, supplying kits for export to England and elsewhere.
