

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

A shift to higher quality materials and design that will alter the building supply market. This could be a painful transition for some companies so may need support, however it is clearly a necessary transition. It could also have a boon of new industry building in Scotland

Increased costs would include, additional training, materials, possibly longer building times, additional external review. Whether these additional costs can be balanced or not, it is clear that these changes are completely necessary to balance our environmental check and move towards net zero.

I would propose a government led, means-tested assistance program depending on the income/net worth/turnover of the organisations building the housing. With increased use of more sustainable materials, then the prices would also go down.

There may be some transition assistance funding required too.
