## Proposed Domestic Building Environmental Standards (Scotland) Bill

### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

The proposal is a robust and reliable means to ensure housing is fit for climate change with very low emissions and provides healthy environments for all people, including the most vulnerable, especially as we face the impacts of a changing climate.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

The legislation is required. Where it is left voluntary and incentivised uptake is much lower. See the Brussels region, for example, that had a successful rapid transition from some of the worst buildings in the EU (for climate change and occupant health etc) to some of the best because they legislated passivhaus.

#### Please explain the reasons for your response.

There is ample evidence from existing passivhaus projects (eg Hostoe Housing and Exeter City and European examples) demonstrating that Passivhaus is a reliable and robust means to effectively eradicate fuel poverty. Other approaches often suffer from a "performance gap" where reality doesn't live up to the good intentions and expectations of the design.

Passivhaus provides a robust and reliable means to significantly cut energy needs in housing, thereby significantly reducing operational emissions of houses. It does this while enhancing the indoor environmental conditions the occupant's experience which is incredibly important for vulnerable people.

## Please explain the reasons for your response, including your views on how effective the process would be in removing the 'performance gap' and on how the proposed verification process might work in practice.

Fully supportive, however, additional training and education and technical resources would benefit the industry gearing up for Passivhaus to be the new normal. More accredited Passivhaus verifiers will be needed, and maybe building control authorities should have them on staff also to undertake verification services. Where the building control authorities don't have PH verifiers on staff they need competent staff to check the verifications that they receive.

#### Q6. What could be the market effects of the introduction of this proposal?

Maybe some initial increase in design and construction costs, but these would even out/disappear in a few years as can be seen from examples from Europe (eg data from Austria, Brussels) and North America (eg data from Pennsylvania where Passivhaus is incentivised for social housing), and Scotland would soon be exporting high-value skills, expertise and products that come out of such a change.
