Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

The immediate effects would probably be an increase in the price of new housing as builders adapt to new practices. However, there is no lack of profitability with most of these firms. Market forces dictate that they would try to keep these costs to a minimum and they might even try to use the improved energy efficiency as a selling point.
