

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

All of these new standards will have to consider the zero carbon emissions, and what systems are being adopted for fuel conservations, and more importantly affordability. Currently we have performance parameters in current building standards so why can't we progress this to a new standard in the same format as a new Housing Quality Standard introduced in 2005. Older buildings prior to this new format should fall into line to bring the quality up to standard including EESSH2 etc.

Q6. What could be the market effects of the introduction of this proposal?

Cost of Housing building will rise unless the Scottish Government takes out restrictions on this and introduces better subsidies for new build. Costs of rents will rise unless there is a rents freeze on all existing builds.
