# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

#### Please explain the reasons for your response.

Only potential downside is a slight increase in initial cost of development which is more than offset by the benefits to occupant health, occupant comfort, decreased fuel poverty, decreased carbon emissions etc. The increase in initial cost can often be completely offset by careful planning and consideration of the form factor.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I would say it is required as often new builds in Scotland have problems with mould growth, overheating and poor ventilation resulting in poor occupant comfort/health. Additionally, current building regulations keep getting closer to Passivhaus standards so I would be doubtful that in 20 years we will be constructing to anything less than PH standards anyway. The benefit of making PH a requirement over working to near PH standards is that there is a clear, defined, tried and tested methodology for achieving PH standards.

#### Please explain the reasons for your response.

If my flat was built to PH standards my heating and hot water bill would be <£50 for the year. As it is not I was spending £60 a month on heating and hot water over winter so I switched the heating/hot water off to save money. Luckily I am young and so i am not as badly effected by this but I would not want any elderly person staying in a home without heating over winter. If this legislation was passed the government would also have to give out less money to help those in fuel poverty.

#### Q6. What could be the market effects of the introduction of this proposal?

I believe very little. Building to PH standards used to increase costs up to 20% but as components have become cheaper and people have become more experienced this has dropped to closer to 3%-10%. With careful planning and good form factor there is no reason why a PH building should cost substantially more to build. I believe we should be promoting a good form factor for all buildings to achieve this.
