

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Please explain the reasons for your response, including your views on how effective the process would be in removing the 'performance gap' and on how the proposed verification process might work in practice.

It's important that clear and concise standards are laid out to avoid ambiguity or confusion. Fuel poverty is increasing but a consistent and clearly understood process to achieve Passivhaus standards in the short term would go a considerable way to help reduce the 'performance gap' in the near future. Regarding the verification process, the 'verifiers' should be within the Building Control Department to ensure consistency, minimise bureaucracy and ensure that 'all the dots are joined'. However, if this is likely to increase costs in an unacceptable way for local authorities, with a negative impact on other services and communities, then the work might be contracted out or undertaken by independent professionally-trained verifiers. If the latter then proper scrutiny of methodology and outcomes would be needed - again to ensure consistency.

Q6. What could be the market effects of the introduction of this proposal?

Research has indicated that building to Passivhaus standards does not mean higher build costs as savings to offset can be made elsewhere eg in 'simplifying design and architectural detailing'. This will be very important to ensure that a negative impact on affordability is avoided.
