Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Employing verifiers is complicated. In the worst case, we have seen the use of private building control companies contributing to the Grenfell tragedy through a lack of professionalism and or ethics. Conversely, local authority budgets tend to be so constrained, officers employed directly may not have the time to verify comprehensively, this may be compounded with the added complexity of verifying a passivhaus.

Q6. What could be the market effects of the introduction of this proposal?

Upskilling of the construction workforce will be required, developers will probably put up prices while they learn how to achieve the standard, many if those working in design will be overjoyed. 'Sustainable' architecture firms may see an uptake in workload initially, though after a year or two will no longer be able to differentiate themselves from all other architecture firms.
