

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Increased construction cost, as greater investment is needed in a super insulated building fabric, quality triple glazed windows and doors and air tight construction . Increased demand for passivhaus products will make the market more competitive.

It is estimated that passivhaus construction costs approximately 10-15% more than a "standard" build. However this cost is off-set within 10-15 years by reduced running costs for the building user - potentially even quicker with rapidly rising energy costs.
