

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

The drive to have fully insulated houses is one of the key requirements in achieving the necessary reduction in our carbon footprint. Ensuring that all new houses are built to the passivhaus standard will ensure that at last the dragging of feet in the construction industry on energy efficiency is ended. This will also act as a driver to the necessary process of upgrading the quality of insulation in our existing housing stock.

Obviously, houses built to this standard would be more expensive to build. Builders would be reluctant to take that cost on themselves so will pass it on as part of the cost of the building. This needs to be seen in conjunction with the need to move away from the detached out of town housing estates into denser housing options that are required as part of the removal of the need for the daily use of cars etc.
