

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

**Please explain the reasons for your response.**

New-build housing makes a large contribution to the UK's carbon footprint and minimum environmental design standards would be effective in reducing this. The adoption of less technically onerous standards than Passivhaus - such as the Sero Life standard for net zero housing - may be a pragmatic way of achieving improvements whilst limiting the need for widespread accreditation / costly upskilling of industry practitioners.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I think legislation would be the most effective way to achieve the Bill's aims, as housing is often constructed to minimum standards in the interests of cost and spatial efficiency.

Whilst constructing to a higher energy efficiency standard may support the ongoing electrification and decarbonisation of the national grid, new build housing alone will not significantly contribute to the eradication of fuel poverty, which will continue to be an ongoing concern with existing housing stock.

The widespread adoption of these standards will contribute to this aim by meaningfully reducing the operational energy demand from new-build housing, but as mentioned previously a less onerous standard, similar to the Sero Life net zero new build housing specification, may be more easily adopted in the short term.
