# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Domestic heating is a huge proportion of our energy need and it makes no sense for it to be any more than the minimum necessary. There can be no justification for new build homes to be any less efficient in energy usage than we know they could be.

Build costs will be higher. That cost will be recovered by the occupier in the long term in lower heating costs, but the developer will just see it as increasing their costs at no benefit to them. Developers will need to make the argument that their properties are worth more. Without legislation bad developers will exploit the general rise in new property prices by building cheap inefficient homes and marketing them at the higher prices.
