

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

There is no logical justification for continuing to allow housing to be built that does not meet the readily achievable performance/efficiency delivered by Passivhaus. Continuing to add to the retrofit burden is irresponsible and an unfair burden to place on future generations.

Without legislation the vast majority of builders will continue to build poorly performing housing and use techniques to avoid meeting even the current standards, e.g. selectively pre-testing air tightness on specific properties in larger developments. I firmly believe that unfortunately it will take legal obligation to ensure an increase in building standards is achieved.

It is reasonable to expect housing built to Passivhaus standard to cost more at the point of purchase, however, the reduction in energy costs over the lifetime of the building offset this. It is impossible to accurately predict future energy cost, but it seems reasonable to assume that over the lifetime of a building the savings will outweigh the additional construction costs, particularly as these reduce over time due to efficiencies of scale and as Passivhaus construction experience grows.
