# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Adopting this approach will address key issues such as poor workmanship and quality, value for money, current full poverty, poor internal conditions which affect occupant health and well being.

Yes I think legislation is required. The baseline of design and build quality currently relates to technical standards, which are seen as required to comply. This baseline needs to raise to address the points previously mentioned. To address initial hurdles such as industry training and uplift costs, financial incentives should be in place to encourage training and clients/developers to pursue passivhaus standard rather than the baseline of technical standards.

#### Please explain the reasons for your response.

Scotland has had an issue with fuel poverty for a long time. Given it is a developed country in the 21st century, it is disappointing that fuel poverty still currently exists, and is heading in the wrong direction with the ongoing cost of living crisis. #### Please explain the reasons for your response.

Passivahus helps address carbon emissions associated with operational energy, which last the life span of a building. All new builds are generally designed for circa 50 years lifespan, this means the housing stock will still be around in 2050 (when Scotland will be net zero carbon). It is therefore paramount that housing designed and built now should be prepared to meet this standard.

Please explain the reasons for your response, including your views on how effective the process would be in removing the 'performance gap' and on how the proposed verification process might work in practice.

Passivhaus projects are designed to PH principles and use the PHPP as a design tool (not only for verification purposes). This is a key process which starts prior to planning submission as it considers elements such as form, massing and orientation - all items which relate to planning- and throughout the project process. Passivhaus standards and verification should be by third parties, separate from statutory authorities (planning and building standards) as there are some conflicts of priorities (eg. conservation considerations by planning) but also there is already a huge demand on these services at present, and any increase in demand will have a significant impact on all local authorities. However, it is important for statutory authorities to have relevant training on the subject to inform their approval processes and decisions.

Q6. What could be the market effects of the introduction of this proposal?

Lack of knowledge or experience by main developers but also sub-contractors and suppliers. Increased house prices as a result of initial uplift may further discriminate against key groups of the population - low income households or those on benefits, first time buyers etc.

Some increased costs to the developers/contractors due to uplift in materials (triple glazing), airtightness tapes but also airtightness testing on site. Increase in training costs which will impact businesses and the public sector if statutory bodies are to receive even a basic understanding of the training. There are currently free training workshops provided by BE-ST (formerly CSIC) which I think are incentivised by the Scottish Government. As mentioned previous, increased cost to end consumer (any construction uplift cost likely to be passed from developer/contractor to end user/buyer) - might cause further discrimination to groups - couple be resolved by some financial support/incentives from the government.
