

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Because Passivhaus certification requires airtightness and measures it, substandard build cannot achieve certification. It requires much more careful building, by those who take pride in the quality of their work.

Q6. What could be the market effects of the introduction of this proposal?

Major housebuilding companies would have to up their game considerably. The TrustMark scheme could be used to assure inspection standards. Imported energy costs would fall over time. Scottish firms would manufacture decent triple glazing with external blinds, and export worldwide.

There is evidence that the additional cost of Passivhaus is no more than 7%. That is less than 1 year's house price inflation, so is immaterial. Existing lesser quality houses will fall in price. Builders will have to

absorb about half the cost increase, and over time it will be negligible. There will be savings from not having to pipe in gas.
