# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Q1. Which of the following best expresses your view of the proposed Bill? Please note that this question is compulsory.

#### Please explain the reasons for your response.

The incorporation of a proprietary standard or system in legislation or associated regulatory instruments is inappropriate: the Scottish Government has no control over how that standard is prepared and implemented, nor do Passivehaus standards go through the same degree of public sector scrutiny as - for example - changes to the Building Regulations or Technical Handbooks. If the Scottish Government wishes to improve thermal performance and energy efficiency strategies in new dwellings then there exist sufficient mechanisms within the current Handbooks to permit this to be done in a recognised, transparent way under the direction of Ministers rather than an external third party.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

The aims could be achieved through revision to the thermal insulation and energy efficiency mechansims already set out in the Building Regulations and Technical Handbooks.

Q3. Which of the following best expresses your view on setting the Passivhaus standard or a Scottish equivalent as the most appropriate new build housing standards to contribute to eradicating fuel poverty?

#### Please explain the reasons for your response.

The term "Scottish equivalent" prejudges an outcome: it may be that there are aspects of Passivhaus that are not suitable for Scotland and would therefore not translate into the existing regulary framework. A more detailed expert assessment is required (as happened, for example, in respect of the recent ban on the most flammable forms of cladding) before such terminology can be used with any confidence. A more appropriate wording to this question would have been "improved Scottish performance criteria" or similar. Setting that to one side, however, the paper does not present any substantive evidence that this would have such an impact when many of those living in fuel poverty live in existing properties. A more expedient approach to retrofit, including grant support, would have a greater impact.

Q4. Which of the following best expresses your view on setting the Passivhaus standard or a Scottish equivalent as the most appropriate new build housing standards to contribute to a reduction in emissions?

#### Please explain the reasons for your response.

The term "Scottish equivalent" prejudges an outcome: it may be that there are aspects of Passivhaus that are not suitable for Scotland and would therefore not translate into the existing regulary framework. A more detailed expert assessment is required (as happened, for example, in respect of the recent ban on the most flammable forms of cladding) before such terminology can be used with any confidence. A more appropriate wording to this question would have been "improved Scottish performance criteria" or similar. Setting that to one side, however, the paper does not present any substantive evidence that this would have such an impact given that the majority of such emissions arise from existing building stock with poor standards of insulation. Better value for money would be achieved by targetting retrofit of 20th Century properties which form the bulk of our domestic housing stock.

Q5. Which of the following best expresses your view of the process set out to ensure that the new standards are met in all new build housing? (see pages 14 to 16 in the consultation document)

Please explain the reasons for your response, including your views on how effective the process would be in removing the 'performance gap' and on how the proposed verification process might work in practice.

The proposal as currently set out does not adequately address the implications of adoption of a third party standard within the Scottish regulatory framework: it is simplistic and fails to take account of capacity at local authority level or likely cost impact across the sector.

Q6. What could be the market effects of the introduction of this proposal?

The adoption of a proprietary third party standard - or the direct translation of that into the Technical Handbooks - will, in my view, act to discourage or restrict other solutions within the marketplace. It will drive up costs at a time of tender inflation. It will also require very significant investment by designers and contractors to upskill to the required level in a way which would, in all fairness, require a significant leadin period together with training support.

### **Financial Implications**

a significant increase in costs

Passivehaus requires a significant change in both design approach and construction techniques on site, which in turn carry a cost implication. These are not reflected in the claims set out in the paper presented in support of the Bill. In contrast evolution and improvement of the current requirements is likely to be more cost effective as it builds on systems already in place.
