Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

I think a team to verify standards should, as an interim provision, include Passivhaus certifiers. In regard to the 'performance gap', introduce spot-checks on builders, change the consumer protection law, and prepare to withhhold completion certificates.

Changes in building standards will lead to improved lifestyles in this case. These improvements should outweigh the financial costs incurred through most costly verification checks. But since this is done to improve practice in planning, design and building the costs will lead to more relevant, and higher levels of professionalism in regard to ecology and sustainability.
