

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

I think that the performance gap would be removed if the Passivhaus system was followed fully although I can see resistance to using one system like this. Ideally, an independent 'Scottish' equivalent would be developed that would be every bit as effective as Passivhaus, although I'm not sure how realistic this would be. The Passivhaus system has been in development for over 30 years and it's hard to see how a 'Scottish' system could be developed to the same standard quickly. Maybe the answer is to convince people of the independence and impartiality of the Passivhaus system and use this, but I can see the opportunity for vested interests who don't want to be led down this route to attack it as 'foreign', 'biased', 'unsuitable for Scotland' etc etc

Q6. What could be the market effects of the introduction of this proposal?

The cost of materials for new housing would increase eg MVHR units. New training would have to be undertaken by housebuilders to ensure that quality standards were maintained. Architects would need to be trained in the new design standards. Overall costs would increase, but savings would be made long term - within the time period of hitting net zero by 2045.
