# Proposed Domestic Building Environmental Standards (Scotland) Bill

#### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

#### Please explain the reasons for your response.

I think that while it is important to continue raising minimum energy efficiency standards in new build housing, there is a greater amount of efficiency improvements to be made in upgrading existing housing and any new bill should reflect this priority. I think that targeting full passivhaus compliance on new build may not be economic. I also think that these measures should not be limited to residential buildings.
