Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

Please explain the reasons for your response.

It is simple Passivhaus is a proven method of achieving the goals defined by this Bill. It is the ONLY method of construction that is independently checked and verified. An analogy would be does the law let you MOT your own can? Rightly it does not, it requires an independent assessor, all other building methods are self assessed. If you allow builders to self assess there is a risk that they will cut corners or apply "that's near enough" standards. Independent assessment is essential to ensure compliance.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

There needs to be set standards in building regulations and legislation is the best way to enforce this. To explain myself I need to look at the horrific events that took place at Grenfell; here the industry was allowed to set standards and the industry is driven by cost and profit hence the rush to drive down commodity prices with the result that cladding was not of the required specification.

Mandating a safe and effective proven standard will ensure that standards are met and maintained.

Material prices will drop once the demand for the "correct" items increase and more suppliers enter the arena. The cost premium for Passivhaus will erode in a relatively short period of time.

I can fully understand the political reasons for saying a Scottish Equivalent but why reinvent the wheel? Yes bring it under Scottish control by having "Nationally appointed assessors" and make it Scottish that way. The Scottish climate has to be considered at design stage and the importance of building to those standards is of vital importance. Government controlled assessment is a method of reducing the overall cost of Passivhaus construction.

The process shown is very good but your own flow chart identifies the VITAL missing link and that is "Independent Assessment" of the build. The solution is simple; adopt Passivhaus as the standard and also then appoint trained and qualified assessors to slot into that gap. This will ensure the ends are met and the action will reduce the overall cost of Passivhaus implementation.

As Passivhaus is currently more expensive there will be a short term increase in cost but this will be recovered by not having to upgrade the stock being built now!! The cost of the expensive products will

reduce as demand increases!!

Senior government figures have stated the housing stock being built now is not fit for purpose and will need to be upgraded to meet known future standards despite this knowledge we continue to build knowing that a further 20 to 30% of the original cost will need to spent in less that twelve years to meet the 2035 requirement that the Government themselves have set.
