

Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Given the chronic shortage of suitably insulated homes already there is a huge need for all new build housing to meet a higher standard of energy efficiency to eliminate the need for future retro fitting when inevitably the need for further carbon reduction measures will need to be enhanced more and more. Current building standards do not limit the residual energy loss enough especially when consideration is given to the Scottish climate and need for additional energy use in winter in comparison to the rest of the UK
