# Proposed Domestic Building Environmental Standards (Scotland) Bill

### Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Embedding the Passivhaus experts in the building control department or even embedding the expertise sounds like the most efficient way to do this but it is important that the personnel involved become enthusiasts for the technology and fully support the objective. Training on the technology and the need for it will be required and possibly a manager within Building Control may need to take full-time responsibility for the implementation and ongoing management of this element. I don't trust the industry and some legal claw-back should be considered for buildings that do not conform to standards.

Q6. What could be the market effects of the introduction of this proposal?

Housing costs will go up. As the standards become commonplace some of the initial costs should come down but by how much? Where the Council is the customer it should lead in using new methods such as factory-built pre-fabs where practical. Not sure if government incentives are required if the new standards are mandatory since market prices will respond automatically. If subsidies for the excess are to be considered they should apply to the home owner not the builder.
