Proposed Domestic Building Environmental Standards (Scotland) Bill

Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

Any houses not built to Passivhaus standard now, will need to be retrofitted in the future, in a process that will be costly and disruptive. It is smarter and more cost effective to move to this higher standard for new build as soon as possible. Passivhaus has the opportunity to significantly reduce our carbon emissions, and to create warmer, more comfortable homes, that cost less to heat. While there are many excellent developers building great homes in Scotland currently, there is no consistent, effective quality control process across the board - resulting in misery for many new home buyers in Scotland who end up with a house that costs more to heat than it needs to, and is uncomfortable to live in. our business from buyers of sub-standard new build homes - "why is my new house cold?" The QA process that is central to Passivhaus build, ensures that problems of performance gap are avoided.

Legislation is required. Don't leave it to the market! Don't leave it to the guarantee companies. Set standards, and fund the enforcement of these standards. As a back-up, create an effective remediation process that ensures that any problems discovered after occupation are also resolved, without the need for home buyers to revert to expensive legal action. While consumer affairs are a reserved matter, there is opportunity for local authorities or others to be given power to enforce remedial work. The current system sees many buyers of new homes, giving up on complaining about heat loss, or selling up and moving on. The current system fails Scottish home buyers.
