

# Proposed Domestic Building Environmental Standards (Scotland) Bill

## Introduction

A proposal for a Bill to introduce new minimum environmental design standards for all new-build housing to meet the Passivhaus standard or a Scottish equivalent in order to improve energy efficiency and thermal performance.

The consultation runs from 4 May 2022 to 27 July 2022

**Please explain the reasons for your response.**

I am not keen on sealing a house completely in what is essentially a plastic bag. I don't think that is a healthy environment. I am very keen that all new housing stock is extremely well insulated and makes good use of passive solar gain, so it is maybe just an issue of terminology that stops me from being fully supportive. Also in a damp, cool and windy climate like Scotland, I think some additional heating will be needed in the cooler months. Passive house standards require no additional heat in a building

Yes. Commercial developers at the cheaper end of the market will continue to try to do things as cheaply as possible with as little effort as possible. I have seen the short cuts and poor workmanship of so called professionals and have to say that the amateur builders I have known work to a better standard and actually care about what they are doing.
